The International Code Council (ICC) administers the Permit Technician Certification exam. Current examination cost: Computer based exam \$199 / Paper-and-Pencil exam \$199. Exam costs are subject to change, check the ICC website Exam Cost for up-to-date information.

Keeping your Certification Current

In order to keep your certification current, you will need to renew it every three years. Certifications must be renewed on or before the expiration date to qualify. A few months prior to the renewal, you will be sent a notice along with a renewal application. If for any reason you do not receive this notice, you may obtain an application from the ICC website. The renewal application also comes with an affidavit for CEU credits. You must have at least 1.5 CEU credits per 3 year period to review your Permit Technician certification. If you have multiple certification and they are all due on the same date as your Permit Technician certification, you must include enough CEU credits for each type of certification renewal. Check the ICC website for the most current information on CEU credits requirements for renewal as well as current renewal costs.

Q: How do I begin the process for certification?

A Permit Technician's Advice on the Exam

The exam was designed to be "self-study". This is something you can study for and achieve without a structured class. Since the exam is open book, just learn where and how to find the information, and you will do fine. Go with the answer that is most correct. The answers may be tweaked to be almost right, except for a word or two. If the answer says "may require" and the code says "shall require", whichever best fits "shall" would be correct. The codes were written such that people shall comply with the code.
