NJATA is pleased to announce that Assembly Bill A1351 (formally A2720) passed unanimously through the Assembly on March 13, 2008 and was referred onto the Senate where it is awaiting review by the Community and Urban Affairs committee. The Bill S1437 is currently sponsored by Loretta Weinberg and Thomas Kean, Jr. and co-sponsored by Paul Sarlo.

Now is the time to call your Senators and tell them about Senate Bill \$1437. Many associations have mailed letters to there senators which will help them recognize our bill. In addition to letters they need to hear from you personally. Please visit the website to find your representative and give them a call to let them know this issue is important to you.

If the bill fails to go through the senate this session we will start from scratch. We will have to re-introduce it in the assembly again, making it a third trip through. We need your help.

Did You Know?

<u>Did you know?</u> There was a change to the requirement for handrails for stairs. The old "3 or more risers" has been replaced in the 2006 IRC NJ Edition.

The new code sections is:

R311.5.6 Handrails. Handrails shall be provided on at least one side of each continuous run of treads or flight with four or more risers.

Please check the handouts that you may use to be sure they reflect the new requirement.

<u>Did you know?</u> Bulletin 07-3 of the NJ UCC spells out the requirements for Ice Dam Membrane/Ice Barrier.

The Building Subcode and the One- and Two-Family Dwelling Subcode contain requirements for roof coverings; in particular, the underlayment and flashing sections specifically require an "ice dam membrane" or

"ice barrier" in Section 1507 and Section R905, respectively, in areas where the average daily temperature in January is 25°F or less. For the State of New Jersey, this area is Sussex County.

The only exceptions to the ice dam membrane requirement, where the requirement applies, are detached accessory structures that contain no conditioned floor area.

For specific roof covering installations, please refer to appropriate sections of the Building Subcode and the One- and Two-Family Dwelling Subcode, as applicable.


ICC Representative Roland Hall Attends NJATA Annual Meeting


Building Safety Conference News
