Dear Construction Official,

This is to call your attention to certain changes that were proposed to the New Jersey Administrative Code in the New Jersey Register of Monday, June 2, 2014. The adoption notice for these changes will appear in the New Jersey Register of Monday October 6, 2014. This pertains to the fees collected by the construction officials on behalf of DCA.

Chapter 23 – Uniform Construction Code

- 5.23-4.19 New Jersey State permit surcharge fees
 - (a) (No change.)
 - (b) Amount: This fee shall be in the amount of [\$0.00334] **\$0.00371** per cubic foot volume of new buildings and additions. Volume shall be computed in accordance with N.J.A.C. 5:23-2.28. The fee for all other construction shall be [\$1.70] **\$1.90** per \$1,000 of value of construction.

These changes will increase the amount of the fee to \$0.00371 per cubic foot on new and addition permits, and the alteration fee to \$0.00190 per dollar of cost of alteration.

The date of implementation of the fee change will be Monday, October 6, 2014.

If you use the State UCCARS program, there are several steps required in order to properly record and account for these changes. Please see the enclosed UCCARS instructions.

If you use the State PermitsNJ system, DCA will affect the fee change on October 6^{th} centrally in the system for all towns for permits issued on or after that date. You will need to run the State Permit Fee report at the close of business on October 6^{th} , and retain this copy to submit with the final copy that you will run at the end of the quarter.

<u>Instructions for users of other construction permit software:</u>

If you use another construction permit management software, now is the time to inform your software provider of these requirements. Contact your software vendor. Your program will need to be able to do the following:



- Calculate the fees based on the new rates October 6, 2014.

For your convenience, a DCA Fee 'rounding' chart has been enclosed.

Q. & A.

Q. Do we need to change our municipal fee ordinance?

A. Not for the DCA State Permit Fee. State Permit Fee is collected under the authority of the New Jersey Administrative Code, and the State has itself effected the changes to the New Jersey Administrative Code. Note that if your fee ordinance references any of the departmental fees in 5:23-4.20 (State standard fee schedule) all of these have changed and may require a fee ordinance revision. - Q. If the application was made before the fee change date, but not issued or paid for until after, do I charge the new or old fee.
- A. It is based on the application date. If an application was completed and accepted by your office before the fee change, you can charge the fee in effect at the time of application

Instructions for UCCARS System 1 USERS:

On Monday, October 6, 2014: You will need to complete entering all of your permit work from permits and permit updates issued before October 6, 2014, BEFORE you make the system changes.

On October 6th, you will need to change the rate in your system:

Go to Change Program Setup.

Go to DCA Fee Change.

Change the Rate Per Cubic Foot Volume New and Addition to 0.00371.

Change the Rate Per Dollar Cost of Alteration to 0.00190

Press F10, then press F2 to store.

You will also need to print a copy of the State Permit Fee report on the 6th, before entering any new permits. Retain this copy and submit it with the regular copy of the report you will print at the end of the quarter.

Change the Rate Per Cubic Foot Volume New and Addition to 0.00371.

Press F10, then press F2 to store.

You will also need to print a copy of the State Permit Fee report on the 6th, before entering any new permits. Retain this copy and submit it with the regular copy of the report you will print at the end of the quarter.
